

2021 PRESIDENT'S ACTIVITY REPORT

INTRODUCTION

The year 2021/2022 has seen the continuation of The General Secretariat and changes in the Technical Department with the resignation of Saloman Dormeus and the hiring of Damekio Been as Equipment Manager and Peterson Evariste as our First Strength and Conditioning Coach. Additionally, we had the resignation of Victor Lowe as President of the Men's Football League and he was replaced by Ira Baptiste. Despite these changes, a streamlined and uniformed strategy continued in the approach to promote and develop our National Teams and Youth Programs progressing through 2022.

Following TCI Government approval, the TCIFA reopened its Grassroots Programs in May 2021. Unfortunately, shortly thereafter, the TCIG Ministry of Sports implemented regulations stipulating the weekly testing of all players. As this placed a heavy financial burden on both the TCIFA and Parents, the TCIFA once again postponed its return to play. Despite this setback, the TCIFA's National Teams sustained their training regime and were provided with multiple opportunities for competition locally, regionally, and internationally.

Despite the ongoing global pandemic, the TCIFA saw much success with our Men's National Team traveling to the Dominican Republic to compete in the FIFA World Cup Qualifiers; our Men's National Beach Soccer Team traveling to Costa Rica to compete in the Concacaf Beach Soccer Championship; and our Women's Under 17 National Team traveling to Bradenton, FL to compete in the Concacaf Women's Under 17 Qualifiers. Along with these International Competitions, the TCIFA hosted a successful Boys and Girls International Friendly against USVI in July and a well-received Women's International Friendly in August 2021 against USVI, Bahamas, and the Cayman Islands.

The 2021 year closed in anticipation of the coming year and the potential to build upon the skills, experiences, and wisdom learned as the TCIFA navigated the uncertain waters COVID 19 presented.

FUNDRAISING/SPONSORSHIPS/EVENTS

<u>Fundraising:</u>

• All activities that involve public participation (fundraising, sponsorship, donations, etc.), including the Annual Golf Scramble and Silent Auction; the Annual "Kick for a Cause" Corporate 7v7 Football Competition; and the TCIFA's Walk-Run-Ride were suspended due to the ongoing COVID 19 Pandemic.

Sponsorships:

 - Continues to share in our vision for the development of Football within the TCI and has been classed as a Diamond Sponsor for their commitment to sponsor and support the TCIFA's Fortis League and Inaugural Elite Youth Fortis League during a 4-year period. The 4-year period commenced in 2020 until 2023.

Events:

- <u>International Women's Day</u> was celebrated by the TCIFA's Women's Football Department on March 8, 2021 via a virtual celebration. President Sonia Fulford, Hon. Akierra Missick, and Head of Women's Football Lisa Garland were the honored attendees of this event and provided words of wisdom and guidance to our female players.
- <u>Football For Friendship</u> WNT and U17WNT Player Rosaria Talbot was nominated and selected to participate in the International Children's Social Programme Football For Friendship. This program was held virtually and united young players, journalists, and children from all over the world who have a passion for sport to participate in team building games, activities, and workshops.
- Launch of GOAM <u>"Girls on a Mission" (GOAM)</u> is a community outreach service program, developed by the Assistant to the Director of Women's Football – Olivia Graveley. This program brings together a group of young female leaders who are committed to giving back to the local communities of the TCI. They promote the empowerment of women through projects and workshops and are guided by the principles of community-service and the desire to create positive change.
 - <u>Project 1 Pick Up for Progress</u> took place on the dates of July 23 -24, 2021 with a team building workshop hosted on July 23, 2021 and litter clean up day taking place on July24 in the communities of Venetian Road and Blue Hills.
 - <u>Project 2 Big Sister Workshop</u> took place on December 17, 2021 with guest speakers Dr. Anya Malcolm-Gibbs (Psychologist) and Sherry Williams (Life Coach). A select group of 12 female players were chosen to participate in this program whereby they were provided with the tools and guidance needed to select a "mentee" from their local communities and were tasked with being a "Big Sister" assisting these "mentees" with issues such as: Self-Love, Boundaries, & Consent; Body Image; Social Circles; Social Media; and Goal Setting and Motivation.



NATIONAL ACADEMY

The TCIFA is continuing in its quest to improve and upgrade our facilities to a state whereby we will have a complete all-purpose football facility. Currently and as part of the FIFA Forward Project and other initiatives, the following work is ongoing or coming on stream:

- <u>National Team Long-Term Accommodations:</u>
 - Due to lack of repairs and service of the Long-Term Accommodation acquired by the TCIFA in 2020, the TCIFA decided not to renew our Lease and instead sought new accommodations in November 2020. As a result of this search, the TCIFA secured a 3-bedroom guest house located on South Dock Road for a period of 12 months (1-year).
 - The TCIFA has therefore been able to continue the provision of adequate accommodation in Providenciales, for our National Players, Coaches, and Ancillary Staff, who reside on the various unconnected islands (Outer Islands) – Grand Turk, South Caicos, and North/Middle Caicos.
 - Thus, ensuring that these Outer Island Players receive the full benefits of training, competition experience, and use of the FIFA standard facilities, it requires the transportation of these players from their home island to Providenciales and subsequently housing them while they reside in Providenciales. The overall objective of which is to support all TCIFA National Teams by facilitating participation in regional and international competitions.
 - This long-term National Team accommodation came equipped with 1 king bed in the Master Bedroom and 2 queen beds in the 2 additional bedrooms. TO better utilize the space, the TCIFA removed the 2 queen beds and replaced them with 6 twin bunkbeds (12 Beds in total). Additionally, the long-term National Team accommodation was equipped with necessary items such as: Bedding (Sheets, blankets, pillows, etc.) Dishware, Utensils, Drinkware, Cleaning Supplies, Cookware, etc.
 - $\circ~$ Despite being restricted by Covid, the TCIFA was able to utilize these facilities throughout the year:
 - To house, 2 chaperones as well as 7 U15 Girls and 3 U15 Boys from Grand Turk, South Caicos, and North/Middle Caicos prior to their departure to Port St. Lucie, FL for the Port St. Lucie Boys and Girls U15 International Friendlies. – March 26 – April 1, 2021
 - To house 10 U15 Girls players and 2 chaperones from Grand Turk, South Caicos, North/Middle Caicos as they participated in an the TCIFA's U15 International Friendly against USVI. – June 30 – August 5, 2021
 - To house 5 U15 Boys players from North Caicos, Grand Turk, & South Caicos as well as 1 chaperone during a training camps held during *May 14 16, 2021; August 5 – 22, 2021 –* preceding the 2021 CFU Challenge Series; *and August 29 – 30, 2021 –* following the 2021 CFU Challenge Series.
 - To house 4 Senior Women's National Team Players and 1 chaperone as they
 participated in the TCIFA's Women's Football Festival. July 29 August 2, 2021



- To house 11 U17 Women's National Team players and 1 chaperone during the dates of *May 28 30, 2021, June 17 20, 2021, September 17–19, 2021; September 24 26, 2021; October 1 –3, 2021, and October 8– 10, 2021* as they participated in several U17 Women's Training Camps held in Provo.
- To house 3 Men's National Beach Soccer Team players that traveled to Provo to attend the Beach Soccer Training Camp held prior to the National Beach Soccer Team's departure to Costa Rica or the 2021 Concacaf Beach Soccer Championship. – May 14- 16, 2021
- To house 3 staff from the outer islands that participated in the Concacaf C License Course *October 18-12, 2021*
- The leasing of this facility was a major success as it allowed our players, coaches, and other ancillary staff from the Outer Islands as well as those traveling from other international locations, to partake in the training sessions, events, and activities held in Providenciales. With this success and until such time as our dormitory project as been completed, we have renewed the lease for 2022.
- Construction of Futsal Pitch and Renovation of the Beach Soccer Pitch:

This project is almost complete as we write as we are only awaiting the installation of the goals.

- <u>Renovation of Grass Pitch</u>
 - Certification of Artificial Turf Field granted by FIFA on February 22, 2021
 - Renovation of Grass Pitch with Platinum Paspalum Grass Playing field has been resurfaced and new Platinum Paspalum Grass was planted in January 2021. We utilized this new grass turf during our participation in our U15 Girls & Boys International Friendlies and the International Women's Football Festival held in the summer of 2021.
 - Upgrade to main grass pitch lighting from 500 to 750 lux all new lighting materials arrived on island as of March 2, 2021. Work on the installation of the new lighting fixtures commenced on March 10, 2021 and is currently completed..
- <u>Removal and Installation of New Boundary Fencing</u>
 - An agreement was made, on February 24, 2021, with Fritzmond Dorsainvil to begin work on the removal of the existing boundary fence at the TCIFA National Academy and the installation of new fencing, to include new boundaries and a rolling gate. Work commenced on March 1, 2021 and was completed on April 1, 2021.
- <u>Installation of Security Cameras</u>
 - S.I.M Contracting (Leonardo Robinson) was drafted to perform an inspection and provide a quotation for the purchase and installation of security cameras at the TCIFA National Academy in March 2021. As per his inspection, it was recommended that the TCIFA acquire and install 18 cameras that would encompass the 2 main buildings, both fields, both entrances,



and the storage facility. Dove Security was ultimately contracted and retained to complete the purchase and installation of all security cameras and security software.

COACHING AND COACHING EDUCATION

Courses held in 2021 include:

- FIFA Guardians Safeguarding in Sport Diploma (2 years): under the FIFA Forward development program, member associations and confederations are required to "take measures to protect and safeguard children and minors from potential abuses and to protect their wellbeing within football".
 - Andrew Edwards, Zekeya Hall, Yunelsis Rodriguez Baez, and Dane Ritchie were nominated to participate in this course.
 - First course: FIFA Guardians: Safeguarding Essentials became open on January 28, 2021 and completed by all participants by February 5, 2021. A FIFA Webinar was held on February 25, 2021 as an introduction to the course and to provide an outline on how the course will progress.
 - Course will be completed in 2022.
- The TCIFA hosted a Concacaf "C" License course that was held during the dates of October 8-12, 2021 with participation of 17 volunteer coaches and staff and was led by local Coaching Educator, Damien Grant. This course was a part of the B License Assessment, conducted by Concacaf Coaching Educator Lenny Lake and commenced immediately following the completion of the "C" course.

GRASSROOTS

- Approximately 650 kids in the program at the start of 2021; 65 in North Caicos, 70 in South Caicos, 90 in Grand Turk, and 425 in Providenciales.
- Launched on September 9 in Providenciales and May 3 in North/Middle Caicos, Grand Turk and South Caicos.

MASTERS LEAGUE

• The TCIFA's Over-35 Master's League launched on January 15, 2021 and took place over the course of 2 weeks. However, with the suspension of football activity, the Master's League did not resume until May 9, 2021, with finals held on June 11, 2021. The culmination of weekly matches resulted in the crowning of the Realest FC as the 2020/2021 Champions, with Cheshire Hall FC taking 2nd place and the SWA Sharks taking 3rd place.

<u>REFEREES DEPARTMENT</u>

- The Refereeing Department continued online zoom technical training sessions, in collaboration with the Bahamas Football Association. Physical sessions were sent to each referee to complete on their own or in small groups.
- With the resumption of Football Activity in May 2021, physical sessions were held in person which were integrated with technical preparation.



• In August 2021, the Refereeing Department launched a youth referee program to develop young referees to officiate youth leagues.

Referee RAP Course

• Wilkiens Martin and Ancie Bernadin participated in the Bahamas RAP Course for Referees, between the dates of October 7-11, 2021. Both participants failed to successfully complete their fitness tests, however, Ancie Bernadin retook this test during the dates of November 16-19, 2021 during the Grenada RAP Course. As she passed her second attempt, Ancie was nominated to the FIFA Assistant Referee List for 2022.

Bahamas Beach Soccer MA Course

• Wilkins Martin and Dane Ritchie participated in the Bahamas Beach Soccer MA Course held between the dates of November 5-7, 2021.

CFU Challenge Series

• Wilkiens Martin secured his first selection to officiate an international match during the 2021 CFU U14 Girls and Boys Challenge Series that was held in the Dominican Republic in August 2021. During the course of his appointment, Wilkiens participated in 4 matches (2 as Referee and 2 as Fourth Official). Ancie Bernardin excelled in this tournament an officiated as an Assistant Referee in the Tier 1 Final Game.

Referee Level 1 Course

- Led by Concacaf Instructor and Elite Assessor, Dianne Ferreira James and supporting instructors Dane Ritchie and Kwabena Wright, this course detailed the FIFA Laws of the Game. Fourteen participants, from across the TCI took part in this course during the dates of November 19-21, 2021.
- This beginner's referee course was funded by the TCIG and facilitated by the TCIFA aimed to assist the TCIFA in increasing its pool of officials and improving the Refereeing Department's standard of officiating.

MATCH COMMISSIONERS' DEPARTMENT

- Consisting of 6 Match Commissioner's: Damona Taylor, Tamara Hall, Sabuton John, Zekeya Hall, Uriel Gilbert, and Giselle James-Wright; the TCIFA Match Commissioner's Department worked diligently throughout 2021 to elevate the level of football within the TCI, providing structure and procedures to pre-match protocols and match preparations.
- Zekeya Hall, was appointed by Concacaf to act as a Match Coordinator during the 2021 Concacaf Women's Under 17 Championship, held at the IMG Academy in Bradenton, FL during the dates of October 20 November 3, 2021.
- Ms. Hall successfully officiated 3 matches.

Elite Fortis League

• The Elite Fortis League launched on Saturday, July 12, 2021, with 127 players from across the TCI participating throughout the months of June and July. Fifty-nine matches were played throughout the course of the league with the Provo Eagles winning the 2021 Fortis League Championship.

Women's National Team:

- In preparation for the 2021 Concacaf Women's Qualifiers, the TCI Women's National Team (TCIWNT) participated in over 20 training camps between January 2021 December 2021. Unfortunately, due to the ongoing COVID 19 Pandemic, this qualifying tournament was postponed until 2022. However, the TCIWNT was able to showcase the skills earned from their thorough training in the TCIFA's Women's Football Festival. This Women's Festival was held during the dates of July 29 August 1, 2021 and include WNT teams from the Cayman Islands, Bahamas, and US Virgin Islands.
- The TCIFA sought approval and was granted Tier 1 status for the Women's Football Festival, therefore, this tournament also included 6 FIFA Referees and our local Referees: Wilkiens Martin, Ancie Bernadin, Leonard Suckrajh as 4th officials.

U17 Women's National Team

- Due to the small population size of the Turks and Caicos Islands, the player pool for female athletes is somewhat limited, and as such, many of our female players are included in all of the Senior Women's, Under 17 Women's, and the U15 Girls National Teams. The TCIFA's Under 17 Women's National Team, therefore, received training for the full year of 2021 as they would have also participated in various other National Team competitions.
- In this regard, the U17 Women's National Team (TCIWU17NT) was aptly prepared to participate in the 2021 Concacaf Women's Under 17 Qualifiers that was held at the IMG Academy in Bradenton, FL, USA. During the dates of October 20 November 2, 2021, the TCIWU17NT participated in Group C of the Concacaf Under 17 Qualifiers against Honduras, Guyana, and Anguilla

Women's League:

- Commenced with the Apertura Rounds on May 29, 2021 with the participation of 6 teams: SWA Sharks, Teachers, Flamingos, Cheshire Hall, Academy Eagles, and Revolutions FC. Teams were 11 v 11 and consisted of players from different ages with the participation of a team of coaches. The tournament proved extremely motivating for the participating teams. Each team was responsible for its own statistics thus strengthening the values of honesty through the application of the rules of the game as well as the promotion of Fair play as referees were not utilized during any of these matches.

- In preparation for the 2021 Concacaf Men's Beach Soccer Qualifiers in May 2021, the TCIFA temporarily contracted an International Beach Soccer Coach from Italy. It was our aim to condition and train our Men's National Beach Soccer Team so that we may provide the most competitive team to represent the Turks and Caicos, especially following almost 2 years of inactivity.
- The Concacaf Beach Soccer Qualifiers took place during the dates of May 17-20, 2021, in Alajuela, Costa Rica. The TCI's Men's Beach Soccer Team competed in Group C of this competition against: USA, Costa Rica, and Trinidad & Tobago.
 - TCI vs USA: 1-11 May 17, 2021
 - Costa Rica vs TCI: 5-1 May 18, 2021
 - Trinidad & Tobago vs TCI: 7-5 May 19, 2021
